Under an August 2 deadline to file its 2012 taxes, the nonprofit Burning Man has declared its first annual loss, predicting a \$3.8 million deficit. There's no tax refund for the 2013 festival, which begins Aug. 30, and Burning Man officials say losses will continue as the company -- which never charges admission to the temporary art event in the Nevada desert -- sells tickets to the counterculture festival this year. (AP Photo/Charlie Riedel) The annual post-holiday rush to pay last year's tax bills is almost upon us. But if you haven't already, it's time to start thinking about your income tax bills and filing them by the Oct. 15 due date. There are three major events going on this filing season: • You'll need to itemize on your income tax to determine whether you're eligible for tax deductions on various personal expenses. An Internal Revenue Service publication has that information. The publication can be found at www.irs.gov or by calling the IRS at 800-829-1040. • You'll need to file your 2013 taxes. The deadline for filing your tax return is April 15, 2014, but if you don't file by that date, you could face penalties, the most common being a 25 percent penalty for each month you delay past the filing deadline. You can use the IRS website or call 800-829-1040 to get information about your tax filing requirements. • If you've reached retirement age, you'll need to figure out if you're eligible for Social Security benefits. The "generous" amount of that benefit is currently \$1,408 a month, and the average retirement benefit is about \$1,200 a month. The information mentioned above doesn't just apply to those who file their own income taxes. It also applies to retirees who file as part of the federal retirement system, Social Security.
